

IOWA SART/SANE

Sexual Assault Response Teams/Sexual Assault Nurse Examiners

Many communities in Iowa have developed or they are developing sexual assault response teams (SARTs) to coordinate immediate, high quality, multidisciplinary, victim-centered response to sexual assaults. A timely, victim-sensitive and coordinated response to sexual assault can increase the likelihood that victims will seek follow-up assistance and long-term support to promote healing, whether or not the victim files a formal police report. Thorough evidence collection can increase the credibility of the prosecutor's case in seeking to convict an offender. In the absence of such a response, victims may encounter law enforcement officers and medical personnel who lack the training to respond to sensitively to sexual assault victims and to appropriately assist victims, conduct forensic exams, and preserve evidence.

A SART is established by creating a multi-disciplinary team and community protocol with representatives of law enforcement, victim advocacy, prosecution, and emergency medical/nursing personnel (Sexual Assault Nurse Examiners are RNs who are specially trained to conduct a forensic examination independently). The first Iowa communities began organizing SARTs in 1997.

This document includes the Iowa CASA member organization/agency, serving the Sixth Judicial District counties. SART and SANE activities in Iowa counties are continuously changing, if there are changes to your SART, please contact medicaladvocacy@iowacasa.org with your county in the subject line and the list will be updated.

The Sixth Judicial District prioritizes seeking services and works collaboratively with agencies who have SART and SANE trained staff. This ensures that victims of PREA related incidents are examined by a Sexual Assault Forensic Examiner (SAFE) or Sexual Assault Nurse Examiner (SANE) when possible. However, if a SAFE or SANE are unavailable services are sought by agencies that have other qualified medical practitioners.
